

## **FOREWORD**

---

The Honorable Harold R. Fatzer, Chief Justice of the Kansas Supreme Court, has been requested to prepare an article on the Proposed Judicial Article which is being submitted to the voters of Kansas for adoption or rejection as an amendment to the Kansas Constitution at the General Election in November, 1972. He has done so, and we believe his article is timely and should command the attention of the attorneys and judges throughout the state.

This issue of the BULLETIN also contains summarized tables showing the volume of work in the Supreme Court, the district courts, probate courts, county and city courts of the state for the year ending June 30, 1972.

## THE PROPOSED JUDICIAL ARTICLE

I am pleased to discuss the proposed judicial article—a matter that is of paramount importance to the members of the Bench and Bar as well as every citizen of the state of Kansas. However, I speak only for myself as Chief Justice and as a citizen of this state.

The judicial article may be found in the 1972 Kansas Session Laws at Chapter 392, page 1437. The proposal as adopted by the Kansas Legislature would amend in total Article 3 of the Kansas Constitution. It will appear on the ballot November 7, 1972, as Proposition No. 1, and provides the electors of the state an opportunity to take affirmative steps to substantially improve the judicial system in Kansas.

This constitutional amendment is the result of a consensus made by The Citizens' Conference on Modernization of Kansas Courts which commenced its work in September of 1964. The conferees were not all lawyers; and I think it significant to note that the membership of that organization represented a realistic cross-section of the state's population. The result, therefore, was not a lawyer's call for reform, but a citizens' proposal to improve and modernize the courts of this state. Following the urging of the Citizens' Conference, the Legislature, in 1968, established the Citizens' Committee on Constitutional Revision (also composed primarily of lay persons), and its studies and analysis of the judicial system provided the judicial article in its present form which the Legislature has submitted for adoption, with minor changes.

The judicial system of Kansas was designed to handle the character of litigation prevalent more than one hundred years ago. Only specific alterations have been made in the system as originally adopted (the last being the modernization of selection of Justices of the Supreme Court in 1958). We now find that the present system cannot adequately handle the caseload that requires adjudication so as to provide prompt justice; thus, as has been commented before, justice is denied by mere delay. To be frank, the ingenuity and resourcefulness of legislators, my colleagues on the Bench, court administrators, and interested members of the Bar has reached the limit of effectiveness under our present constitutional criterion, and progress is impaired. In order to assure prompt, fair, and efficient justice, this state must have constitutional judicial reform.

As you are aware, Chief Justice Warren Burger of the United States Supreme Court is an active supporter of judicial reform. At the National Conference on the Judiciary in Williamsburg, Virginia, in 1971, the Chief Justice commented on this pervasive problem of judicial reform:

"The challenges to our systems of justice are colossal and immediate and we must assign priorities. I would begin by giving priority to methods and machinery, to procedure and techniques, to management and administration of judicial resources even over the much-needed reexamination of substantive legal institutions that are out of date."

I concur in the need for priorities and submit that the judicial article is the first step in providing the machinery to effectively allocate judicial resources.

Turning now to specific changes contemplated by the proposed judicial

article, the most significant would be the establishment of a unified court system with supervisory administrative authority over all courts vested in the Kansas Supreme Court. At present, our courts have overlapping and duplicative jurisdictional bases and operate oftentimes with limited administrative supervision. Thus, one court may have an oppressive caseload while another may have *de minimis* docket responsibility. Overall court administration would provide a system by which caseloads could be effectively monitored and would substantially improve the efficient administration of justice in this state. At present, there is no constitutional authority vested in the Supreme Court for supervision of the courts. The proposal puts an end to the debate whether the Supreme Court should rely on its inherent powers to see that the judicial system operates effectively. The proposal continues the requirement that there be two courts—the Supreme Court and District Courts—and leaves to the Legislature the creation, continuation or abolition of other courts as the needs of the people may be determined. This means that the Legislature as well as the Bench and Bar can give serious consideration in the future to the creation of an intermediate court of appeals, a reform which I consider greatly needed.

With respect to the Supreme Court, the proposed judicial article provides for at least seven justices (the present number) and continues the requirement that four justices participate in a case and concur in the decision. While seniority is retained for a basis for the selection of the Chief Justice, a justice may decline or resign from the office of Chief Justice without resigning from the Court. This provision, coupled with mandatory retirement presently in effect, removes much of the criticism against the seniority method for selection of Chief Justice. District court judges may be assigned to temporary service on the Supreme Court, thus providing additional manpower when the need arises.

The Constitution presently prohibits Supreme Court justices and district court judges from practicing law "in any of the courts in the state," while in office. (Art. 3, Sec. 13.) The proposed judicial article would delete the language "in any of the courts in the state," thus removing any doubt as to the prohibition against a district judge or Supreme Court justice from practicing law—be it in court or out of court. This would be in keeping with the code of judicial ethics.

The judicial article would continue the prohibition against justices of the Supreme Court from making political contributions or participating in political campaigns. The prohibition would also apply to district court judges in districts adopting a system of nonpartisan selection and tenure.

In addition, as impeachment has not been shown to provide a viable tool whereby unqualified judges may be removed from service, the constitutional amendment would permit the discipline, suspension, removal, or retirement of judges for cause by means other than the cumbersome remedy of impeachment.

Under the new judicial article, the legislature would be authorized to establish procedures whereby the electors of each judicial district in the state may upon local option approve or reject a system of nonpartisan selection of district court judges within their districts. In those districts rejecting the nonpartisan option, judges would continue to be elected by political ballot.

Other miscellaneous advantages include: 1) continuation of the office of clerk of the district court but removes the requirement that the clerk be an elected county official; 2) incorporates the statutory requirement that justices of

the Supreme Court and judges of the district court be at least thirty years old and licensed to practice law in Kansas, and 3) eliminates the present constitutional requirement that there be specified courts of limited jurisdiction.

It should be noted that the judicial article would not repeal any Kansas statute relating to the Supreme Court, district courts, probate courts, magistrate courts, nor would it repeal any statutes relating to the justices or judges of those courts. The present statutes would remain in force and effect until repealed or amended by the Legislature through implementing legislation which would abolish any court or adjust the term of office of any present judge. However, the constitutional amendment would enable the Legislature to ultimately reorganize the various branches of the judiciary under the unified administration of the Kansas Supreme Court.

In conclusion, the judicial article must not be considered by the citizens of Kansas as a panacea for the procedural ills that now permeate our judicial system. More important factors to be considered are the investigation and reorganization of the present system by legislative enactment to make the system more sensitive to the needs of the people; the implementation of research and educational programs to increase the awareness of all Kansas citizens with the continuous need to review our judicial system periodically to facilitate improvement in the administration of justice at all levels of judicial experience, and, finally, the responsibility of the Bench, the Bar, and all Kansas citizens to suggest and recommend procedures that will enable the administration of justice to continue to be prompt and less costly to the parties in litigation and the taxpayers. The judicial article is a condition precedent to substantive change, and provides the basic foundation necessary for a system which provides the efficient adjudication of controversies that is the foundation of any free society.

The courts of this state are not the private possession of judges and attorneys; rather, they belong to the people. It necessarily follows that the people must support the judiciary if it is to maintain its awesome responsibility to provide a stable medium through which social change materializes. I urge you to read the new judicial article and familiarize yourself with its advantages. I ask that you recommend to your fellow citizens to vote "Yes" for Proposition No. 1 on November 7, 1972.

Once again, I would thank the judicial council for an opportunity to discuss the proposed constitutional amendment and trust that my thoughts have met a receptive forum.

## Summary of the Work of the Supreme Court

The following is a summary of the work of the Supreme Court for the year ending June 30, 1972, and the cases pending July 1, 1972.

The Supreme Court disposed of 373 cases during the year. Included in the total terminated by the Court were 236 appealed civil cases, 96 appealed criminal cases and 41 original cases.

Of the total civil appeals, 122 were affirmed, 59 were reversed, 34 dismissed, 20 affirmed in part and reversed in part, and 1 remanded.

Of the appealed criminal cases, 53 were affirmed, 16 were reversed, 26 dismissed, and 1 affirmed in part and reversed in part.

Of 41 original cases, the Court dismissed 17 cases, entered judgment for plaintiff in 4 cases and for defendant in 17 cases and 3 with other terminations.

The Supreme Court also issued 1599 orders prior to final disposition of cases pending during the year and in addition ruled upon 62 post-decision motions.

During the year 32 appeals were also docketed in the Supreme Court under Rule No. 6 (j). In such cases, 13 applications for intermediate orders were granted, and 19 were denied. In 17 cases, the regular appeal was docketed and in 15 cases the appeal was either pending or terminated in the district court by the end of the fiscal year.

There were 9 applications for permission to take interlocutory appeals (Rule 5) filed in the Supreme Court, 6 of which were denied, and 3 allowed. Three applications for permission to take an interlocutory appeal in criminal cases (Rule 17) were filed. All were granted.

Pending in the Supreme Court as of July 1, 1972, were 321 cases, of which 249 were appealed civil cases, 60 appealed criminal cases and 12 original cases. The average number of cases pending on July 1, for the past ten years is 315.

During the year ending June 30, 1972, opinions were filed in 279 cases terminated by the Court. In 230 cases opinions were filed on or before the first regular opinion day; in 16 cases on or before the second regular opinion day; and in 3 cases on or before the third regular opinion day. Thirty cases were decided on the day they were submitted.

The regular opinion day is ordinarily a month after the case is submitted, more accurately it is the Saturday of the week hearings are had the next month after the case is submitted.

In 202 appealed civil cases in which opinions were filed within the year ending June 30, 1972, the time between the day the case was docketed in this Court and the date the case was submitted on its merits was as follows: Within three months, 2 cases; in three to four months, 2 cases; in four to six months, 15 cases; in six to eight months, 12 cases; in eight to ten months, 12 cases; in ten to twelve months, 2 cases; and in over twelve months, 157 cases.

In 72 appealed criminal cases in which opinions were filed during the year ending June 30, 1972, the time between the date the record was filed in this Court and the date the case was submitted on its merits was as follows: Within three months, 1 case; in three to four months, 3 cases; in four to six months, 13 cases; in six to eight months, 12 cases; in eight to ten months, 2 cases; in ten to twelve months, 5 cases; and in over twelve months, 36 cases.

In the forty-five years that the Clerk of the Supreme Court has furnished us detailed information of the work of the Supreme Court, it has disposed of 18,676 cases, of which 5976 were dismissed before submission, and 12,700 were submitted on the merits and written opinions filed.
