

FOREWORD

Following our customary practice, we have asked the Honorable Harry O. Janicke, of Winfield, president of the Bar Association of the State of Kansas, and whose photograph is shown on the cover, to prepare an article on a subject of his own choosing for publication in this issue of the BULLETIN. He has done so, and we believe that his article on "Kansas Is Ready for the Organized Bar" will be of particular interest to attorneys throughout the state.

Mr. Janicke was born at Hanover, Kansas, on December 14, 1902, and attended grade and high school at Washington, Kansas. He attended the University of Kansas and the University of Colorado, and was graduated from the K. U. Law School and admitted to the Bar in 1924. He was a member of Delta Tau Delta social fraternity and Phi Delta Phi legal fraternity.

After graduation, he was in turn an advertising salesman, a deck hand in the Merchant Marine, a jewelry store handy man, a stenographer, and finally a collector for the International Harvester Company, before going to Winfield in 1927 to practice law with Lucius D. Moore, later the firm of Moore and Janicke. After the death of his partner in 1932 he practiced alone until 1946, at which time he became associated with John A. Herlocker under the firm name of Janicke & Herlocker, now Janicke, Herlocker & Bishop.

He was married in 1941 to Willmerth Cravens of Tulsa, Oklahoma. They have two sons, Bill and Joe, who, respectively, have provided two grandsons and two granddaughters.

He is a member of and former vestryman of Grace Episcopal Church, a member of the Rotary Club, Director of the Chamber of Commerce, Trustee of William Newton Memorial Hospital, Trustee of The H. L. Snyder Memorial Research Foundation, and a former City Commissioner and Mayor of Winfield, Kansas. He was chairman of the Selective Service Board for Cowley County during World War II. He is a member of the Cowley County and American Bar Associations and has served on the Executive Council of the Bar Association of the State of Kansas since 1951.

This issue of the BULLETIN also contains summarized tables showing the volume of work in the Supreme Court, the district courts, probate courts, county and city courts of the state for the year ending June 30, 1962.

Between now and the first of the year another Special Report, in the form of a Bulletin, showing the work of the Advisory Committee down to date, in connection with the revision of the code of civil procedure, will be issued.

Kansas Is Ready for the Organized Bar

The organized bar has, of course, generally become known as the Integrated Bar. I had several lawyers from Arkansas and Mississippi tell me they were attempting to get away from this latter term as "integrated" was a dirty word in their area.

As of the present time, there are 27 states, plus Puerto Rico and the Virgin Islands, which have an integrated bar.

The term "integrated bar" describes that type of unified State Bar to which every practicing lawyer in the state belongs. It differs from the traditional and voluntary bar association in two essential respects: (1) The integrated bar has official status. It recognizes the role of the lawyer as an integrated part of the judicial machine. (2) The integrated state bar includes all the lawyers in the state.

There have been three different methods by which integration has been achieved: (1) By statutory enactment under the state's general police power to regulate professions; (2) direct Supreme Court rule through the Court's inherent power to control lawyers as officers of the Court; and (3) a combination of legislative and judicial authority.

I have done considerable checking on the status of the states having an integrated bar and without exception wherever a unified bar exists the judges and lawyers praise its usefulness and general effectiveness in carrying out the public responsibilities of the legal profession. As an organized arm of the judicial branch of the Government the integrated bar enjoys a relationship and an influence on the other agencies of the Government that the voluntary bar association can never have. The official status of the state integrated bar lends weight to its legislative proposals involving the administration of justice and helps it in its dealings with the other organizations and agencies in and out of the Government.

The integrated bar is all inclusive. Every lawyer has an opportunity to participate in formulating the policies which are enunciated by his professional organization.

When the integrated bar speaks on problems involving the administration of justice its voice is hard for any elected official to ignore. The fact that *all* lawyers are within the ranks of the integrated bar facilitates a successful ethics and disciplinary program. The integrated bar, under the supervision of the Supreme Court, polices its own members in accord with the basic American principle of self-government and for the general public benefit.

Since every lawyer pays dues to the integrated bar, there are sufficient funds to finance such important undertakings as are of benefit to the lawyers, the public, and the more efficient administration of justice. A voluntary association such as we now have wastes a needless amount of money, time and energy in building up the membership roster. This time, energy and money can therefore be devoted to obtaining the aims and objectives that are the real reason for the existence of the association.

It has been the experience in many other states, that many lawyers who did not belong to the voluntary bar association and took no interest in its affairs have reversed that position with the integrated bar and have become active and enthusiastic workers within the association.

North Dakota was the first state to integrate its bar in 1921; Alabama and Idaho followed in 1923; Wisconsin and the Virgin Islands in 1956 have been the most recent. Oklahoma, Missouri and Nebraska all have integrated bars.

Constitutionality of the integrated bar has now been firmly established by the United States Supreme Court decision handed down on June 19, 1962, in the case of *Lathrop v. Donohue* wherein the Supreme Court of the State of Wisconsin was affirmed. The case arose out of the fact that Trayton L. Lathrop, a Madison, Wisconsin, lawyer had challenged the constitutionality of the integrated bar by paying his annual dues under protest, alleging infringement of his rights of freedom of association and freedom of speech.

The obligations of membership in an integrated bar are as simple and reasonable as the requirements for driving a car. Just as a motorist pays a license fee and obeys traffic regulations in exchange for the privilege of driving, a member of an integrated bar pays nominal annual dues and observes standards of conduct in exchange for the privilege of practicing law. He is not required to do anything else except as he recognizes the valuable public service he may perform through their official organization and chooses to play an active role.

My closest personal knowledge of an integrated bar comes by reason of my location close to the Oklahoma line and I have yet to hear criticism from any Oklahoma lawyer or judge. The bar was integrated in Oklahoma by court order. The court then adopted and promulgated rules created to control and regulate the Oklahoma Bar Association. Then the House of Delegates of the Oklahoma Bar Association adopted its by-laws laying down the rules for the transaction of its business.

In Oklahoma each county has a grievance committee. Each Supreme Court judicial district has a grievance committee. Under the disciplinary rules in Oklahoma the executive council makes a preliminary investigation, either by a grievance committee, or an examiner, or an employee of the association, and the lawyer involved has an opportunity to be heard in the course of the preliminary investigation and a report is made to the executive council. The charges may then be dismissed, may be referred to a grievance committee or an examiner, or may direct that a formal written complaint be prepared and proceedings be commenced. Formal proceedings can be brought only upon order of the Supreme Court or by direction of the executive council. The formal complaint is brought in the name of the State of Oklahoma, *ex rel.* Oklahoma Bar Association. Proceedings are not made public and the record is private and confidential, unless the respondent shall request otherwise, or unless the executive council or the trial authority shall otherwise order. Upon it being shown that the matter has been so publicized or that the respondent has so conducted himself that the ends of justice or the public relations of the bar require it, the proceedings shall be public. Punishment may be *private reprimand, public censure, suspension from practice or disbarment*. Respondent has the right to appeal even from a recommendation for private reprimand by the executive council.

It must be admitted, I believe, by all of us that our disciplinary procedure is antiquated, cumbersome and inadequate. Our present association has no authority whatever in dealing with many matters that while they might not be a basis for disbarment are a basis for other discipline.

I speak largely of the Oklahoma rules because those are the ones with which I am most familiar.

The simplification of the disciplinary role is only one of the many reasons that the integrated bar has met with such general satisfaction among the lawyers in those states having the integrated bar. The integrated states have discovered that since integration they have larger attendance at their State Bar meetings; they have had more and willing workers in the business of the bar and through the institution of suggested minimum fees on a state-wide level, although in a number of states varying to meet communities of various sizes, that the over-all income of the lawyers has been materially increased.

Summary of the Work of the Supreme Court

The following is a summary of the work of the Supreme Court for the year ending June 30, 1962, and the cases pending July 1, 1962.

The Supreme Court disposed of 513 cases during the year, an increase of 131 cases over the average for the preceding ten years. Included in the total disposed of by the court, were 418 appealed civil cases, 42 appealed criminal cases and 53 were original cases.

Of the total civil appeals, 130 were affirmed, 49 reversed, 230 dismissed, 4 affirmed in part and reversed in part, and 5 were affirmed as modified.

Of the appealed criminal cases, 14 were affirmed, 2 reversed, 25 dismissed and 1 affirmed in part and reversed in part.

Judgment was for the plaintiff in 1 original case and for the defendant in 37 others. The court dismissed 15 original cases.

The Supreme Court also issued 912 orders prior to final disposition of cases pending during the year and in addition ruled upon 81 post-decision motions.

Pending in the Supreme Court as of July 1, 1962, were 402 cases of which 321 were appealed civil cases, 73 appealed criminal cases and 8 original cases. The average number of cases pending on July 1 for the past ten years is 265.

During the year ending July 1, 1962, opinions were filed in 258 cases. In 3 cases, opinions were filed before the regular opinion day; in 198 cases opinions were filed on the first regular opinion day; in 16 cases on the second regular opinion day; in 2 cases on the third regular opinion day; in 4 cases on the fourth regular opinion day, and 1 on the fifth regular opinion day. Thirty-four cases were decided on the day they were submitted.

The regular opinion day is ordinarily a month after the case is submitted, more accurately it is the Saturday of the week hearings are had the next month after the case is submitted.

In the 202 appealed civil cases in which opinions were filed within the year ending June 30, 1962, the time between the date notice of appeal was filed in this court and the date the case was submitted on its merits was as follows: within 3 months 4 cases; in 3 to 4 months 4 cases; in 4 to 5 months 2 cases; in 5 to 6 months 4 cases; in 6 to 7 months 8 cases; in 7 to 8 months 12 cases; in 8 to 9 months 20 cases; in 9 to 10 months 22 cases; in 10 to 12 months 91 cases and over 12 months 35 cases.

In the 18 appealed criminal cases in which opinions were filed within the year ending June 30, 1962, the time between the date notice of appeal was filed in this court and the date the case was submitted on its merits was as follows: within 4 to 5 months 6 cases; in 5 to 6 months 0 cases; in 6 to 7 months 4 cases; in 7 to 8 months 3 cases; in 8 to 9 months 1 case; in 9 to 12 months 2 cases; and over 12 months 2 cases.

In the 35 years the clerk of the Supreme Court has furnished us detailed information of the work of the court, it has disposed of 15,109 cases, of which 5,088 were dismissed before submission, and 10,021 were submitted on the merits and written opinions filed.
