Foreword

The Honorable F. C. (Tim) Bannon, President of the Bar Association of the State of Kansas, has been requested to prepare an article on the subject of his choosing for publication in this issue of the BULLETIN. He has done so and we believe his article will be of particular interest to attorneys throughout the state. It is entitled "Needed: An Effective System of Lawyer Discipline."

Francis Charles Bannon was born in Leavenworth, Kansas, on January 24, 1903, and was nicknamed "Tim" the same day. He attended the Leavenworth Parochial, Elementary and High Schools. He also attended the University of Wisconsin in 1927 and graduated from the University of Kansas School of Law in 1928. He was admitted to Kansas practice the same year.

He served as judge Pro Tem of the District Court of Leavenworth County in 1956-57. He is a Director of the Kansas State Historical Society and Johnson County National Bank & Trust Company, Prairie Village; Director and Vice-President of the First National Bank of Leavenworth; a member of Delta Theta Phi Legal Fraternity, the Leavenworth County, Kansas and American Bar Associations. He has been a United States Commissioner at Leavenworth since 1950, and has served on the Executive Council of the Kansas Bar Association since 1954.

This issue of the BULLETIN also contains summarized tables showing the volume of work in the Supreme Court, the district courts, probate courts, county and city courts of the state for the year ending June 30, 1965.

The advisory committee of the Judicial Council appointed pursuant to House Concurrent Resolution No. 43 to make a study, report and recommendations of and pertaining to the provisions of the Kansas probate code and other laws relating to the voluntary hospitalization, emergency and other involuntary commitment and admission of persons to mental hospitals, the guardianship of the person and property of incompetents including the mentally ill, chronically physically ill, and the conservation of the estates of such persons, completed its work early in 1965 in sufficient time for the Council to study, make revisions, and approve the proposed legislation for recommendation to the 1965 session of the legislature. Pursuant to recommendations by the Judicial Council the legislature, with some modifications, enacted Chapter 347 relating to estates of incapacitated persons or minors, and Chapter 348 relating to care or treatment for mentally ill persons. These acts, together with Chapter 346 relating to probate judges, courts and procedures, amending the probate code, will be in force from and after January 1, 1966.

Services of the advisory committee have been continued by the Council for the purpose of revising and drafting forms for use in the State of Kansas in connection with these new laws. It is hoped this work will be completed in sufficient time for publication in the December issue of the BULLETIN.

The advisory committee appointed by the Judicial Council to make a study of family law drafted legislation which, with some modifications, was approved by the Council and recommended to the 1965 session of the legislature for adoption. The act, however, was killed in the legislature.

The advisory committee appointed by the Council to work on recodification of the criminal code has been working hard to draft modernized laws within the scope of its authority. On the following pages is a report of the Honorable Doyle E. White, a member of the Council and chairman of this advisory committee.

Supplemental to the report in the October, 1964, issue of the BULLETIN, the committee of district judges appointed by the president of the District Judges Association on July 1, 1963, has been continuing its work on the preparation of pattern jury instructions. They have met throughout the past year, the last meeting being held on August 13 and 14, 1965, at which time the committee completed its work on the proposed volume of pattern jury instructions for Kansas. The material is now in the hands of the publisher, and the completed publication is expected late in 1965. The chapters completed, in addition to those submitted in the temporary publication, cover the fields of eminent domain, owners and occupiers of land, products liability, international torts, and the federal employer's liability act. Any judge or attorney desiring a copy of the proposed instructions in these fields, prior to the publication of the permanent volume, may obtain them by writing the chairman, the Honorable Don H. Musser of Pittsburg, Kansas, or any member of his committee.

Needed: An Effective System of Lawyer Discipline

An invitation to prepare an article of one's own choosing for publication in the JUDICIAL COUNCIL BULLETIN comes to the President of The Bar Association of the State of Kansas each year. If the invitation would read "submit" rather than "prepare," the members of the Judicial Council would find themselves in a much better position to send a politely worded "rejection slip" and return the President's picture to him. The use of the word "prepare" in the invitation implies that the article will be printed, and thereby, the writer will be bound in print by what he writes.

The area of subject matter and Association activities open for discussion and pertinent to Kansas and Kansas lawyers and Courts is broad and varied and cursory examination of the field suggests a discussion of any one of the following subjects:

Public Relations, Improvement of Procedures, The Juvenile Defendant, Modernization of the Courts, Relations with News Media, Bar Related Title Insurance, A Statewide Minimum Fee Schedule Guide, Reorganization of the Bar Association of the State of Kansas, The Lawyers' Place in the War on Poverty, etc., etc.,

and even the culling out of the list to produce the subject to be chosen, is a thought provoking process.

What I propose to discuss in the following paragraphs is a subject which, in a greater or lesser degree will skirt closely around nearly all of the above listed subjects.

The right to practice law under the Canons of Ethics is a privilege bestowed by the Supreme Court and its exercise must be closely supervised and controlled by that Court.

Chapter 7 of K. S. A. deals with the broad activities of lawyers and their practice, from the time of their application for admission to the end of their professional career. Sections 7-103, 112 and 123 provide the qualifications for admission, the Rules of the Supreme Court and the Rules of the State Board of Bar Examiners. Both sets of rules are intended to accomplish the purpose of lawyer discipline.

Over the years, however, there has grown and developed a practice that the Professional Ethics Committee of the Bar Association of the State of Kansas shall investigate and report all complaints of misconduct of lawyers. As such an investigating group, acting without legal authority, and with no power to enforce its decisions, the Committee through its Advisory and Grievance Sections, has performed service above and beyond any expectation. It has found itself in the onerous position of unofficially trying to be official and oftentimes being rebuffed by the lawyer being investigated. Not too infrequently, its carefully arrived at conclusions and recommendations have borne no fruit and misconduct, injustice and crime have gone unpunished and even unprosecuted.

There exists no set of rules for the investigation of the character, morals, ability and probable legal integrity of one seeking a legal education. Many of the ills of the profession might be remedied if strict investigation were required prior to a student's entry upon his prelegal education. To some extent this may be corrected by the crowded conditions of our law schools. In the term now starting the first year law classes at K. U. and Washburn number 150 and 110 respectively. Recently the dean of one of the law schools announced that future enrollment of first year law class students will be limited in number until enlarged facilities are provided. The very act of numerical limitation,

however, may bring about in part a preliminary investigation which may weed out the unfit prior to embarking upon a legal education.

That, however, is only a partial solution. The Statutes, the Supreme Court Rules and the Rules of the State Board of Bar Examiners are aimed at the control of the lawyer in his practice and the Canons of Ethics, opinions of the Professional Ethics Committee and of the ABA Committee are all intended to serve as strict guidelines for his professional conduct. The Canons have been printed frequently in the Kansas Reports. No lawyer can plead ignorance of these Canons or of the opinions thereon. "The Ethics Handbook" recently compiled and edited by Linda H. Asay and distributed to the Association membership is a capably executed work and contains sufficient material to instruct the practicing lawyer in the conduct required of him in his practice.

The vast majority of our Kansas lawyers, over 90% of whom belong to our voluntary Association, practice law and conduct themselves in their personal lives in accordance with the Canons.

But (and in this instance "but" is a word of enormous proportions), complaints of misconduct, unethical practice, and even criminal activity of lawyers exist. A reading of the 1965 Annual Report of the Professional Ethics Committee (34-JBK-116) will acquaint the reader with the magnitude of the work of this informal committee with no authority to fully investigate or to enforce its findings. The Committee often finds itself investigating complaints against lawyers who are not and in some instances never have been members of the Association. Such a lawyer need not answer correspondence from the Committee or may send them from his office.

The long-suffering, hard-working, dedicated people who have in the past and are now serving on the two sections of the Committee are fully justified in the feeling of futility they acquire from working under the Kansas system. Their suggestions of a method to correct the situation range from one pole to the other; from the complete withdrawal of the Association from the field of complaint investigation at one poll to the hope that "something better" will come along and that we should keep on "spinning our wheels" until it does, at the other, notwithstanding the ever-increasing burden of complaints and the time-consuming investigation thereof.

What is needed to enforce the Canons is a set of official rules and procedures, adopted by the Supreme Court and the appointment (and if necessary, the employment) of lawyers and others to investigate all complaints. Such appointees and employees should have full authority to fully investigate complaints, including the power of subpoena. Such rules and procedures have been adopted by other states and efficient control of the situation has resulted. Both the Colorado and Minnesota rules have been recommended by our Committees.

A meeting of the Judicial Council, State Board of Bar Examiners, Association Officers and Council, and Professional Ethics Committee members has been set up to arrive at a solution of the problem. A solution thereof is a *must* and the prompt implementation of the solution is urgent.

The Association owes a debt of gratitude to the Professional Ethics Committee for its work in the past. It is the fervent prayer of the writer that it will soon be relieved of the thankless and unproductive job of investigation which it has gradually taken upon itself.

Recodification of the Criminal Code

The Advisory Committee on Criminal Law Revision concluded its second year of work on September 1, 1965. Monthly meetings of two days each have been held regularly during the past year. Two changes in committee personnel occurred during the year. A. K. Stavely and Howard E. Payne, both of whom resigned on account of health considerations, were replaced by William M. Ferguson of Wellington and Lee V. Hornbaker of Junction City. Other committee members are Doyle E. White of Arkansas City, Chairman, E. Lael Alkire of Wichita, Vice-Chairman, Lester M. Goodell of Topeka and Selby S. Soward of Goodland. Paul E. Wilson of Lawrence is reporter for the committee and J. Richard Foth of Topeka, Assistant Attorney General, represents the Office of the Attorney General in committee deliberations.

Thus far the committee's efforts have been devoted wholly to the revision of the substantive part of the criminal law—Chapter 21 of the General Statutes. The work has been laborious and painstaking and necessarily time consuming. However, the committee is pleased to report that its proposed revision of Chapter 21 is approaching completion. Most of the major categories of crime have been considered and tentative drafts have been prepared. While no section is yet considered final and many will be revised upon further consideration and reevaluation, it is expected that the completed draft of the substantive code will be ready for submission to the Judicial Council within the next few months.

The objective of presenting a clear, concise and coherent code has been the committee's paramount concern. In most areas, this process of simplification has resulted in the elimination of archaic, complex and unnecessary language. To illustrate, the committee has tentatively agreed upon five sections concerning the area of criminal homicide. These sections, the committee believes, cover the field more fully and coherently than the 21 or more sections of the present statute relating to the same subject. Another illustration—by defining a simple generic crime of theft the committee seeks to include the present crimes of larceny, embezzlement, false pretense, and receiving stolen property, thus eliminating troublesome technical distinctions that often appear in prosecutions under the present laws.

The committee is particularly mindful of the deep public concern with the criminal law and its administration. Therefore, it solicits the suggestions of the bar, the judiciary and the public. The committee is grateful for the suggestions that have already been received. The persons forwarding these communications are assured that due consideration will be given to each.

Summary of the Work of the Supreme Court

The following is a summary of the work of the Supreme Court for the year ending June 30, 1965, and the cases pending July 1, 1965.

The Supreme Court disposed of 328 cases during the year. Included in the total disposed of by the Court were 227 appealed civil cases, 65 appealed criminal cases and 36 were original cases.

Of the total civil appeals, 94 were affirmed, 65 were reversed, 44 dismissed, 5 affirmed in part and reversed in part, 5 affirmed as modified, 10 permission to appeal under Rule No. 5 denied, 3 reinstatement of abandoned appeal denied, and 1 dismissal of appeal set aside.

Of the appealed criminal cases 31 were affirmed, 11 were reversed, 22 dismissed, and 1 appeal sustained.

Judgment was for the plaintiff in 1 original case and for the defendant in 29 others. The Court dismissed 5 original cases and in one the respondents were discharged.

The Supreme Court also issued 515 orders prior to final disposition of cases pending during the year and in addition ruled upon 107 post-decision motions.

Pending in the Supreme Court as of July 1, 1965, were 246 cases, of which 163 were appealed civil cases, 74 appealed criminal cases and 9 original cases. The average number of cases pending on July 1, for the past ten years, is 305.

During the year ending July 1, 1965, opinions were filed in 263 cases. In 197 cases opinions were filed on the first regular opinion day; in 13 cases on the second regular opinion day; in 3 cases on the third regular opinion day; in 4 cases before the first regular opinion day; and in 1 case before the second regular opinion day. 45 cases were decided on the day they were submitted.

The regular opinion day is ordinarily a month after the case is submitted, more accurately it is the Saturday of the week hearings are had the next month after the case is submitted.

In the 187 appealed civil cases in which opinions were filed within the year ending June 30, 1965, the time between the date notice of appeal was filed in this Court and the date the case was submitted on its merits was as follows: Within three months, 15 cases; in three to four months, 8 cases; in four to six months, 11 cases; in six to eight months, 13 cases; in eight to ten months, 11 cases; in ten to twelve months, 46 cases; and in over twelve months, 83 cases.

In the 45 appealed criminal cases in which opinions were filed during the year ending June 30, 1965, the time between the date notice of appeal was filed in this Court and the date the case was submitted on its merits was as follows: Within three to four months, 4 cases; in four to six months, 8 cases; in six to eight months, 7 cases; in eight to ten months, 6 cases; in ten to twelve months, 11 cases; and in over twelve months, 9 cases.

In the thirty-eight years the Clerk of the Supreme Court has furnished us detailed information of the work of the Supreme Court, it has disposed of 16,856 cases, of which 5,584 were dismissed before submission, and 10,772 were submitted on the merits and written opinions filed.
